"Light the Spark" Teacher Contest OFFICIAL RULES

NO PURCHASE NECESSARY. Void where prohibited.

All entries must include an essay and completed Contest Entry Form, and all entrants must comply with these Official Rules to be eligible. Essays must be no more than 1,500 words to be eligible. To enter, submit a copy of your essay with a completed entry form. The essay (the "Submission") should tell the story of the unique strengths, interests, or talents of one of your students with a learning difficulty, and why that student should be recognized for his or her milestone accomplishments. Mail the Submission and contest entry form, including your name, address, phone number, school address, and e-mail address, as well as the name, gender, grade, age, and learning difficulty of the student you are nominating, to: Light the Spark Contest, Scholastic Inc., P.O. Box 711, New York, NY 10013-0711. Teachers may submit more than one entry, but only one entry per each nominated student. Only teachers are eligible to enter. Two Grand Prizes will be awarded to the Winning Teacher: one teacher of a boy student, and one teacher of a girl student, and to the nominated student of each teacher as described below. Entrants represent and warrant that they have notified the parent/legal guardian of the student that the entrant wishes to nominate the student in the Contest, and have secured all appropriate permissions from the parent/legal guardian, including without limitation, the right to provide personally identifiable information relating to the student to the Sponsors as part of the Contest. Entrants represent and warrant that they have advised the parents/legal guardians of the content of these Official Rules, including without limitation the fact that federal, state, and local taxes, if any, and expenses not included in prize descriptions are the sole responsibilities of the winners and prize recipients.

Odds of winning depend on number of eligible entries received. Submissions may be used by Sponsor without further permission of entrant. Judging Criteria: Entries will be judged based on the following criteria: Does the entry describe the unique qualities, interests, and talents of the student? Does the entry reflect the student's resiliency and perseverance in managing his/her learning difficulty? Does the entry indicate the student's strengths weighed against his/her learning difficulty? Does the entry describe the student's progress and milestone accomplishments? Does the entry reflect the student's positive self-esteem and compassion toward others?

Prizes: Two (2) Grand Prize—winning teachers—one the teacher of a boy student, and one the teacher of a girl student—will each receive (i) a trip to New York City for an awards presentation in April 2005, a laptop computer, and a \$250 Scholastic gift certificate. Exact date of awards presentation will be included with winner notification sent out on or about 2/16/05. Each Grand Prize—winning teacher package includes round-

trip coach airfare (between the major commercial airport closest to the winner's home and New York City)/transportation, hotel, and meals for two (2) people in New York City (estimated retail value: \$1,990), and (ii) a prize for the nominated student in the winning Submission: one boy and one girl, will each receive a trip to New York City for an awards presentation in April 2005, a laptop computer, and a \$250 U.S. savings bond. Each Grand Prize student package includes round-trip coach airfare (between the major commercial airport closest to the prize recipient's home and New York City)/transportation, hotel, and meals for four (4) people in New York City (estimated retail value: \$2,880).
