CAPTIONED DVDS AND VIDEOS

Weston Woods DVDs and videos are available in closed-captioned format. This format contains captions of the narration plus descriptive text for the hearing impaired. In addition to use by the hearing-impaired. Research has shown that captioned DVDs and videos can help students make improvements in their reading skills, most notably in comprehension and vocabulary. DVDs and videos may be used with captions turned on or off. Open-Captioned format videos are also available. Please call customer service for a list of available titles.

CC/SUBTITLED DVDS — DVDs described as CC/SUBTITLED DVDS include BOTH closed-captioning and subtitles. The closed-captioning includes the descriptive text for the hearing impaired, while the DVD subtitles contain only the spoken

narration and character dialogue for use as a reading tool. Subtitled captions are not highlighted as in our new *Read-Along* feature, as described in the paragraph below. These DVDs may be used with both types of captions turned on or off.

READ-ALONG — This feature allows children to follow each word as it is simultaneously narrated and highlighted on the screen, strengthening vocabulary, comprehension and fluency. All new DVDs now offer three viewing options: Read-Along, closed-captioned subtitles or no text at all.

REPLACEMENT POLICY — Weston Woods will offer a free replacement for any worn or damaged Weston Woods' or Scholastic Audio DVD, CD or audio cassette or VHS purchased on a direct order from Weston Woods for a period of 2 years from date of purchase. 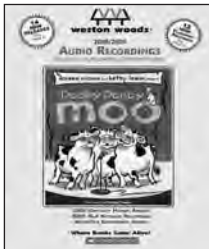
